## APPENDIX

7.3 Brief summary of activities from 2018-2019 - MMHSA President's Activity Report to QFHSA for 2018-2019

2018-19 was an active year for Margaret Manson Home and School Association. In addition to supporting various school related activities throughout the year, we also ran 3 events and 6 different fundraisers. A list of all the activities along with comments are provided below chronologically. Our fundraising objective was to raise $\$ 10,000$ to help fund outdoor play yard equipment for Margaret Manson Elementary, set over a 1 year period (2018-2019). The objective was achieved in June of 2019.

## SEPTEMBER

Elections - held at first meeting of the year

## Bake Sale - Curriculum Night

- offered baked goods, waters, coffee and espresso; profited ~\$125


## Welcome Back Event

- offered pizza, chips and drinks as advance purchases; additional chips, drinks, baked goods and TCBY (grads) onsite
- free activities for kids: button making, tattoos, line dancing, karate demo
- raffled off MMES water bottles with gift certificates inside
- profited $\$ 840$


## Campaign \#1 Sub Lunch Fundraiser - Sept-Oct-Nov

- offered 6" sub lunch + choice of drink + cookie , $1 \times$ per month for $\$ 6.00$ per order ( $\$ 2.09$ profit) with Subway Colisee
- participation rate $=54 \%$ of school - similar to pizza lunch last year ( $50 \%$ rate $)$

Apples for Terry Fox Run- purchased apples for entire school as a healthy snack after run

## OCTOBER

## Membership

- 44 memberships submitted


## Halloween Bingo Night

- sold out Halloween Bingo costume party
- offered samosas, beverages, coffee, chips for purchase on trolleys, a bake sale table and TCBY (Grads)
- over 180 bingo prizes awarded
- additional fun contests/games: best boy/girl costume, guess the candy in the candy jar, guess the weight
of the pumpkin, Pick the Nose of Frankenstein and a Monster Raffle with prizes ranging from \$50\$300
- \$2330 raised in total (\$1540 last year)
- limitations : location in gym too small (max accommodation is 225)

Pumpkins - purchased for each class for decorating

QSP and Mabels Labels - yearlong magazine and clothing label fundraisers launched

## NOVEMBER

## Bake Sale - Parent Teacher Interviews - Term 1

- baked goods and coffee offered for 2 days; generated $\$ 570$ in profits


## Recettes En Pot Fundraiser

- offered recipes in a jar for second year; sales provided jobs to local artisans operating in the social economy and school received one serving of soup with every sale - donated to On Rock
- 50\% profit margins
- \$1439 total raised mainly through online ordering
- NOTES: simple fundraiser if run online; however, online site for ordering still problematic this year; similar profits noted to last year even though fundraiser was moved to run before the Holidays


## DECEMBER

## Families Helping Families

- annual charitable campaign collected 27 boxes of food for On Rock, 100 toys and gifts for Children's Hospital and enough cash donations to purchase 30 turkeys


## Holiday Week

- hosted continental style holiday breakfast for entire school including staff...even Santa visited!provided candy canes for children for Comfy Cozy Reading

Campaign \#2 Sub Lunch Fundraiser -Dec-Jan-Feb-Mar - participation rate ~ 56\%

## JANUARY

## Open House

- provided volunteer support along with baked goods and beverages for Open House


## FEBRUARY

## Bake Sale - Parent Teacher Interview - Term 2

- baked goods and coffee offered; generated $\$ 380$ in profit


## APRIL

## Campaign \#3 Sub Lunch Fundraiser -Apr-May-Jun (x2)

- participation rate $=51 \%$
- 2 fundraiser lunches offered in June to compensate for no cafeteria services- all 3 campaigns raised $\sim \$ 3200$ for entire year


## Staff Appreciation Week

- organized weeklong celebration for all staff in the theme of Paris which included: Espresso and Patisserie bar, multiple breakfasts, a luncheon, Yoga + hydration station, Spirit Day + Love Locks activity with the children, wine and raffle gifts
- Perfect Potluck was an excellent way to sign up for volunteer and food donations


## JUNE

2019-2020 AGM (Elections) - held in June; Google Form used for nominations; recommendation to hold AGM in May to allow for new executive to transition in June and to allow executive time to meet with GB and pass any pressing resolutions in June

K Orientation - offered volunteer services and membership information; supplemented a snack table for adults and kids

Freezies for Power Hour - provided to entire school

## Year End BBQ

- hosted a BBQ for MMES families and staff; offered catered hamburgers, hotdogs, sausages, drinks, popcorn and ice cream truck onsite!
- kids activities: air-brush tattoos, face painting, slime and pin button making \& kids prize zone (NEW)
- raffle for adults with prizes ranging from \$20-\$200
- raised $\sim \$ 1900$ (profits)
- NOTES: catering/food truck helped offset volunteers numbers required at grilling and desert stations;
food trucks however were noted to be very expensive and needed to be carefully planned and budgeted; recommendation to use a sign up sheet for volunteer support and track volunteers submitted by R. Aspiotis - Co-Chair MMHSA 2018-19
